# PUBLIC PARTICIPATION



- **5 countries** - Legislation provides discretion to require public participation in the EIA process
- **4 countries** - Legislation requires mandatory public participation during the EIA process
- **6 countries** - Draft legislation for public participation and/or rely on guidelines or practice

- **12 countries** - Common law legal system  
Right to challenge decisions of public authorities (judicial review)
- **2 countries** - Environmental courts (Trinidad & Tobago; Dominican Republic)
- **2 countries** – Constitutional right to a healthy environment (Guyana and Jamaica)
